AUSD to Connect NBU's Payment System

On 16 February 2010, the National Bank of Ukraine (NBU) approved a Regulation allowing the All-Ukrainian Securities Depository (AUSD) to become a participant in its System of Electronic Payments currently used for interbank settlements in Ukraine.

By having direct access to the electronic payment system operated by the NBU, AUSD is expected to be able to shorten the settlement process as well as improving the settlement efficiency. AUSD and NBU are currently finalising the relevant procedure and rule changes for the implementation of this connection.
