# **BMV Aims to Join MILA Project**

It has been announced that the Mexican stock exchange, the Bolsa Mexicana de Valores (BMV), signed a letter of intent with the Bolsa de Comercio de Santiago (BCS), the Bolsa de Valores de Colombia (BVC), Bolsa de Valores de Lima (BVL) as well as the respective central securities depositories in those markets.

The letter establishes the framework for the Mexican market to join MILA, the integrated exchange and enables those entities to conduct relevant studies and mutually explore certain issues such as operational and technical aspects of the development of this project.
