Reminder on Non-dematerialised Shares

The Central Registry Agency (CRA) has sent a reminder regarding the outstanding non-dematerialised shares.

As per the provisional Article 6 of the Capital Markets Law amended by the Article 157 of the Law No. 6111 which was published in the Official Gazette no: 27857; non-dematerialised shares which are not submitted to issuer companies or intermediary institutions for dematerialisation within 7 years from the beginning of the dematerialisation system, rights of such shares shall be annulled with their legal transfer to issuers.

Shareholders of such stocks have until 31 December 2012 to adjust their holdings accordingly.
