The Central Bank of Chile (BCCh) and the Central Securities Depository (DCV) announced that they are working together in the implementation of the standard for electronic messaging ISO15022 in the settlement process of the BCCh's transactions.

The implementation will be phased in two stages:

- 1. BCCh's repo transactions including the intraday and permanent liquidity facilities.
- 2. The remaining transactions settled by BCCh.
